1. Move It Faster (greater Acceleration), Because There Is Less Mass, Or 2. Push

Less To Move It (use Less Force.) Force Is Measured In Newtons (N) $1 \text{ N} = 1 \text{ Kg M/s}^2$.
(Force) = (mass) X (acceleration) $1 \text{ N} = 1 \text{ Apple}$, Force Is Weight! Weight = Mass X
